Dear Valued NHF Member,

Right now we are all threatened by an ominous and alarming spread of unnecessary but mandatory vaccinations. These FORCED and COERCIVE vaccinations are *in direct and blatant violation of the Nuremberg Code*, which since the end of World War 2 stood for, among other things, the principle of informed consent to medical procedures. It is a shocking violation, **a rape** of the most devious kind – in the guise of protection when in fact it is blatant **abuse!**

Yet, on June 29, 2015, the California State Legislature passed Senate Bill 277 (SB277) into law. Then, emboldened Indiana followed with its own version. This law, which takes effect July 1, 2016, JUST A FEW SHORT WEEKS AWAY, removes the personal-belief vaccine exemption for children attending daycare and public and private schools. **Your rights as parents and guardians are being blatantly stolen from you!** Remember, these “government servants” are acting in direct violation of a Code set into place to protect you against exactly these kind of assaults against your free choice, health, and health freedom.

Despite some of the most articulate, accurate, passionate, and vocal opposition the Legislature has seen from citizens spanning all political, socioeconomic, ethnic, religious, and medical backgrounds, a pro-mandatory, money-hungry vaccination lobby backed by the pharmaceutical, medical, and public-health industries prevailed. *In short ... you lost.* Education for California public and private school children and day-care attendees is now dependent upon the children being forced to have multiple injections of 10 federally recommended and State-mandated vaccines – regardless of a parent’s personal or religious belief objections and despite a growing host of vaccine-damaged people (children and adults alike) to prove this is dangerous and a willful crime against humanity.

NHF strongly opposed the California SB277 bill, which was also opposed by the Association of American Physicians and Surgeons, California Chiropractic Association, California Naturopathic Doc-

tors Association, California Nurses for Ethical Standards, California ProLife Council, California Right to Life Committee, Inc., Canary Party, Capitol Resource Institute, Educate Advocate, Families for Early Autism Treatment (FEAT), Homeschool Association of California, Pacific Justice, Institute Center for Public Policy, ParentalRights.org, Safeminds, and National Vaccine Information Center. In other words: anyone in their right mind. While we support freedom of choice, when you have THIS much opposition, a step back, a re-evaluation of a prior (unilateral) decision is in order. But did we get that respect? No, we were told to roll up our sleeves and take it.

Make no mistake, with the backing of such industry front groups as Immunization Action Coalition (which is funded by Astra Zeneca, BioCSL, Merck, Novartis Vaccines, Pfizer and Sanofi Pasteur and CDC) as well as Biocom (which represents Pfizer, Merck, GSK, Novartis, Sanofi, Monsanto and Kaiser Permanente), this drive towards mandatory vaccinations is a huge threat that demands this call to action!

Even the airlines are thinking of demanding that all passengers be VACCINATED before they board a flight! It is crazy!



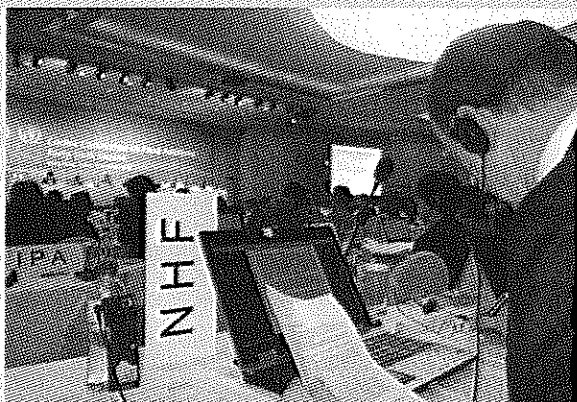
